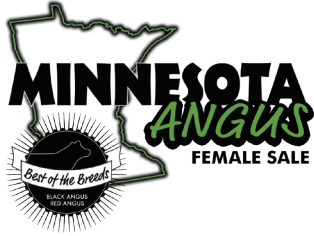

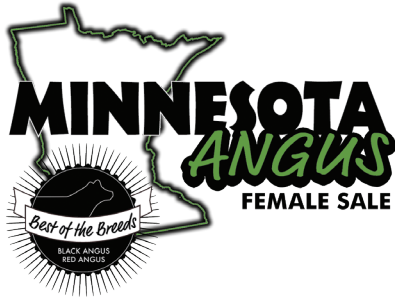

**October 31, 2018 - Entry Deadline (late entry fee of \$250/head). Catalog content and all photos due.**

\*\*Please note, catalog content and photos received after November 2, 2018 WILL NOT BE CATALOGED. No exceptions.

November 2017 - Again this year, the sale will be conducted as a live video auction with all lots being videoed prior to sale day.  
**Video dates and locations are pending, watch for details.**

Fri., Dec., 14, 2018 - Each Breed Association will be holding an Annual Meeting, Banquet, and Social. Details will be disclosed in the sale catalog.

Sat., Dec., 15, 2018 - Black Angus sale will begin at 12:00 noon, with the Red Angus sale following at approximately 1:30 p.m.

## AUCTION RULES & REGULATIONS:

**All sale cattle MUST be halter broke to lead.**

**An entry fee must accompany each entry. Cattle entered without the fee, will not be cataloged. \*New this year, entries submitted by October 15, 2018 will be charged a fee of \$150/head. Entries submitted between October 15 - October 31, 2018 will be charged a fee of \$250/head. Entry fees will be refunded with sale settlement provided cattle arrive and sell on sale day.**

**\*\*Catalog content and/or photos received AFTER November 2, 2018 WILL NOT BE CATALOGED. NO EXCEPTIONS.**

**Sale Format:** The sale will be conducted as a live VIDEO SALE using the same bidding process as a live auction. No sale cattle will be entering the sale ring, but still must be halter broke. Cattle will be available for inspection prior to the sale for bidders attending. Online bidding will be provided for those wishing to watch and/or bid remotely. Additional bidding information will be provided in our sale catalog. Sale will start promptly at noon, with the Black Angus lots selling first, followed by the Red Angus tentatively to start at 1:30.

**Registration Papers:** No cattle will be allowed to sell without presentation of the pedigree. The sale managers will be responsible for the transferring of the registration papers. Costs will be the responsibility of the consignor.

**Health Certificates/Test Requirements:** All animals must have a health certificate and be ready for interstate travel. We are requiring you to have females preg checked prior to sale and confirm all open heifers to be open and breedable. Health papers will need to be turned in at the time of check-in, along with a copy of the registration papers. Each animal must be individually identified with an official USDA tag or registration tattoo accompanied by the registration certificate.
